### For Attorneys Handling Child Protective Services Cases

## Free ABA Teleconference: Youth Transitioning from Foster Care to Adulthood

The ABA [Children's Rights Litigation Committee](#) and the ABA [Juvenile Law Center](#) have developed a series of free teleconference programs focused on the issue of youth transitioning from foster care to adulthood. The series has convened panels across the country to discuss what is currently happening and what needs to happen for this population to assure a successful transition from foster care to adulthood.

The Children's Commission is working with the State Bar of Texas to provide Texas MCLE for the entire teleconference series. Once MCLE has been secured for all five of the ABA's Youth Transitioning from Foster Care to Adulthood teleconference replays, the Commission will send out comprehensive information with links to each of the ABA's replays, so that Texas attorneys can take advantage of any and all of the sessions in this series at their convenience.
